 - Finance & Business Development
 - KPI's for May
 - 1. 3706 rounds were played in May 2021 an increase of 305 rounds from May 2020. Member rounds played was 2628 for 71% of total rounds.
 - 2. Course usage was 64% up from 61% in 2020.
 - 3. Average spend in Pro-Shop was \$13.55 down from 2020 average of \$15.24
 - 4. Average spend in F&B was \$5.75 down from 2020 average of \$12.55
