- 2. Review of past Board of Director Minutes July 8th, 2021.

3. Committee Reports and Updates

## • Finance & Business Development

- KPI's for June
  - 1. 7658 rounds were played in July 2021 a decrease of 661 rounds from July 2020. Member rounds played were 3961 for 52% of total rounds.
  - 2. Course usage was 74% down from 80% in 2020.
  - 3. Average spend in Pro-Shop was \$13.90 down from \$14.13 in July 2020.
  - 4. Average spend in F&B was \$17.64 up from \$12.79 in July 2020.
  - 5. C&G labour per round was \$5.61 up from \$4.65 in July 2020.
- J.D. did a presentation on Tee-On and how it works for the members and staff.
- J.D. will work with Tee-On to improve on it over the winter.
- Decision was agreed on to go to members only tee time until 12:00 PM on the weekends after the long weekend in September.
- J.D. asked our insurance company to appraise the building for insurance purposes. The appraisal came in at \$5,300,000 up from \$3,700,000. Insurance will cost about an extra \$4,000 per year.

- Follow up about financial controls: Signing authority and competitive bid process.
- Finance committee will meet on September 9<sup>th</sup> to go over August financials and discuss signing authorities and competitive bid structure.
